Considering the impact on the environment as a whole is important, this includes the historic environment. Wetlands and waterlogged deposits can include archaeological remains that are extremely sensitive to changes in water level. From a historic parks and gardens perspective, we witness and foresee problems with irrigation water supply and waterlogging; public safety issues about water quality and algal blooms, and dams on large lakes and costs of repairs and conservation challenges of works. In urban areas, we are seeing inappropriate sustainable drainage schemes being forced into historic parks. Urban green space has an important water run off role and the first priority is to improve permeability and if SuDS installations are needed the design needs to respond to the site.
