Planning Response to Covid-19

Given the fast moving nature of responses to the Covid-19 pandemic, we would recommend checking websites such as gov.uk, the <u>Local Government Association</u>, the Planning Advisory Service and others for up to date information.

This section highlights some of the changes introduced, since the last Planning Bulletin, relating to planning and the historic environment, and is not intended as a compendium of all information relating to Covid-19 issues.

Coronavirus (Covid-19): Government Planning Update

- In response to the spread of Covid-19, MHCLG has published an update on planning matters, including temporary measures to make it easier to operate the planning system. The update covers:
 - 1. Community Infrastructure Levy
 - 2. New time-limited permitted development rights
 - 3. Validation of applications
 - 4. Determination timescales
 - 5. Publicity and consultation for planning applications
 - 6. Virtual planning committees
 - 7. Local Plans
 - 8. Neighbourhood Plans
 - 9. Compulsory purchase
 - 10. Nationally Significant Infrastructure Projects
 - 11. Where to go for additional information

Statutory Publicity Arrangements

Under the <u>Town and Country Planning (Development Management Procedure, Listed Buildings and Environmental Impact Assessment) (England) (Coronavirus)</u>
 (<u>Amendment) Regulations 2020</u> the government has introduced temporary regulations to supplement existing statutory publicity arrangements, such as site

notices and newspaper advertisements, for planning applications. Local authorities now have flexibility to take "other reasonable steps" to publicise applications if they cannot be undertaken through the existing specific requirements for site notices, neighbour notifications or newspaper publicity. Such steps must be "proportionate to the scale and nature of the proposed development".

Planning Practice Guidance Updates

- The online Planning Practice Guidance (PPG) on <u>Consultation and Pre-Decision</u>
 <u>Matters</u> has been updated to reflect the temporary regulations relating to statutory
 publicity arrangements (see above). The pages include details of how to determine
 what steps are proportionate.
- The PPG on <u>Plan-Making</u> has been updated to include new <u>paragraphs</u> which set out changes to Plan-making guidance in response to the Covid-19 pandemic. It states, amongst other things, that "where any of the policies in the Statement of Community Involvement cannot be complied with due to current guidance to help combat the spread of Covid-19, the local planning authority is encouraged to undertake an immediate review and update the policies where necessary so that plan-making can continue".
- The PPG on <u>Environmental Impact Assessments</u> has been amended to include a section on the temporary changes to statutory publicity arrangements outlines above.

Ministerial Statement: Virtual Working and Planning

• The Secretary of State for the Ministry of Housing, Communities and Local Government, Robert Jenrick MP, has issued a <u>written ministerial statement</u> on virtual working and planning in response to Covid-19. It covers the role of digital technology, virtual events (such as the Planning Inspectorate's (PINS) programme for moving to digital inquiries, hearings, meetings and other events), digital documentation for applications, updates on guidance on sites visits, publicity and community engagement, and guidance and advice from PINS.

Planning Inspectorate

- Updated Guidance on Site Visits: PINS has published guidance on site visits, and
 hearings and inquiries. It will be commencing site visits where it is safe to do so as well
 as considering whether there are types of cases that can proceed without undertaking
 a visit. It also reports that the first fully digital hearing took place on 11 May as a pilot.
 Following that trial, PINs hopes that at least a further 20 examinations, hearings and
 inquiries will follow during May and June.
- Statement on Local Plan Examinations: Following the government's written ministerial statement PINS has also published a <u>statement</u> on how virtual local plan examinations might proceed.
- Statement on Nationally Significant Infrastructure Projects (NSIPs): in light of government advice on to control the spread of Covid-19, PINS have issued a <u>statement</u> on NSIPs.

Community Infrastructure Levy Guidance

 In response to the spread of Covid-19, MHCLG has published <u>guidance</u> for local authorities on Community Infrastructure Levy matters. Amongst other things, it states that the government will introduce amendments to the Community Infrastructure Levy Regulations 2010 "to enable charging authorities to defer payments, to temporarily disapply late payment interest and to provide a discretion to return interest already charged where they consider it appropriate to do so for developers that have an annual turnover of less than £45 million".

Compulsory Purchase Guidance

- In response to the spread of Covid-19, MHCLG has published <u>guidance</u> for acquiring authorities on compulsory purchase matters. The guidance covers:
 - Compulsory purchase
 - Recently Submitted CPOs
 - Service of documents
 - o <u>Time periods for responses</u>
 - o Return of documents to acquiring authorities
 - o Decisions remitted back to acquiring authorities
 - Dealing with claimants

Taskforce to Develop a Plan to Reopen Places of Worship

- The government has <u>announced</u> it is working with faith leaders to develop a plan to
 enable the phased and safe reopening of places of worship when the evidence shows
 it is the right time to do so. The government previously set out its ambition to reopen
 places of worship in step 3 of its plan to lift restrictions, which is expected to be no
 earlier than 4 July subject to further scientific advice.

Traffic Management Act 2004: Network Management in Response to Covid-19

• The government has issued <u>guidance</u> setting out high-level principles to help local authorities to manage their roads to deal with Covid-19 response related issues. The government "expects local authorities to make significant changes to their road layouts to give more space to cyclists and pedestrians", and that "such changes will help embed altered behaviours and demonstrate the positive effects of active travel". It provides additional information to the original <u>Network Management Duty Guidance</u> (November 2004) and will be reviewed on a regular basis.

Encouraging Cycling and Walking

• The government has <u>announced</u> £250 million emergency active travel fund to help create pop-up bike lanes with protected space for cycling, wider pavements, safer junctions, and cycle and bus-only corridors, in response to requirements such as the need for social distancing. "Following unprecedented levels of walking and cycling across the UK during the pandemic, the plans will help encourage more people to choose alternatives to public transport when they need to travel, making healthier habits easier and helping make sure the road, bus and rail networks are ready to respond to future increases in demand."

Safe Use of Public Space

• The MHCLG has published <u>guidance</u> on enabling safe use of public spaces in light of the Covid-19 pandemic. It focuses on the design principles for safer urban centres and green spaces. It contains "information and examples of interventions that may be undertaken by the owners and operators of public spaces to keep people safe as and when the restrictions are relaxed and urban spaces become busier."

Ministerial Statement: Construction Site Working Hours

• The Secretary of State for the Ministry of Housing, Communities and Local Government, Robert Jenrick MP, has issued a <u>written ministerial statement</u> instructing

local planning authorities to "take a swift and positive approach to requests from developers and site operators for greater flexibility around construction site working hours", for instance by not enforcing, or amending, planning conditions that restrict them. The full contents of the guidance are:

- 1. Existing flexibilities overview
- 2. Instalment policies
- 3. Enforcement
- 4. Section 106

Impacts of Covid-19 Effects on the Heritage Sector

- Historic England has <u>published</u> a survey of the impact of Covid-19 on the heritage sector. It complements that of the National Lottery Heritage Fund (NLHF), whose survey had targeted the charities and third sector organisations which they had previously supported. Amongst others things, the survey showed that nearly four out of five (76%) of respondents report lost business in the short term, and three out of five (58%) had postponed or cancelled income-generating events.
- The Impact of Covid-19 on the Heritage Sector is discussed further in the latest edition of Historic England's *Heritage Online Debate*.

Funding for Business Improvement Districts

The government has <u>announced</u> that Business Improvement Districts will receive £6.1 million in funding in response to the Covid-19 pandemic. The money will be paid to local authorities and dispersed to Business Improvement Districts to help local businesses.

Extended Public Consultations

- The Department for International Trade's consultation on the UK's <u>Freeport Policy</u> has been extended to 13 July.
- The Environment Agency's consultation on <u>River Basin Planning: Challenges and Choices</u> has been extended to 24 September.
- Historic England's consultation on a draft <u>Local Authority Strategic Framework</u> has been extended until 25 May.
- Historic England's consultation on a revised Advice Note on <u>Tall Buildings</u> has been extended to 28 May.
- Historic England's consultation on a new Advice Note on <u>Commercial Renewable</u> Energy and the Historic Environment has been extended to 28 May.

Government Departments

Ministry of Justice

 The Ministry of Justice had published details of its <u>Sustainable Operations Strategy</u>, setting out how it embeds environmental sustainability throughout its estate, operations and procurement activity. It includes nine strategies and policies, to address key topics such as; adaptation to the impacts of climate change, biodiversity and ecology, and heritage and historic buildings.

Legislation and Matters Arising

Secondary Legislation

As reported in the *Planning Response to Covid-19* section (above):

Under the <u>Town and Country Planning (Development Management Procedure, Listed Buildings and Environmental Impact Assessment) (England) (Coronavirus)</u>
 (<u>Amendment) Regulations 2020</u> the government has introduced temporary regulations to supplement existing statutory publicity arrangements, such as site notices and newspaper advertisements, for planning applications.

Written Ministerial Statements

 Details of written ministerial statements relating to <u>Virtual Working and Planning</u> and <u>Construction Site Working Hours</u> are noted in the <u>Planning Response to Covid-19</u> section of this Bulletin (above).

Emerging Legislation

Government Bills

- Agriculture Bill: amongst other things the Bill authorises expenditure for certain agricultural and other purposes; to make provision about direct payments following the United Kingdom's departure from the European Union and about payments in response to exceptional market conditions affecting agricultural markets; to confer power to modify retained direct EU legislation relating to agricultural and rural development payments and public market intervention and private storage aid. The Bill was introduced to the House of Commons and given its First Reading on 16 January. The Bill passed its Second Reading on 3 February and has been considered by a Public Bill Committee which reported to the House on 6 March. The Bill passed its Third Reading on 13 May and will now go to the House of Lords for consideration.
- <u>Clean Air (Human Rights) Bill 2019-20</u>: amongst other things the Bill establishes the
 right to breathe clean air; requires the Secretary of State to achieve and maintain clean
 air in England and Wales; and to enhance the powers, duties and functions of the
 Environment Agency, the Committee on Climate Change, local authorities (including
 port authorities), the Civil Aviation Authority, Highways England, Historic England and
 Natural England in relation to air pollution. The Bill was introduced to the House of
 Commons and given its First Reading on 13 January. The Second Reading is yet to be
 scheduled.
- Environment Bill 2019-21: amongst other things the Bill aims to A make provision about targets, plans and policies for improving the natural environment, for statements and reports about environmental protection, conservation covenants, and about air quality. The Government have reintroduced the Bill and have said that it demonstrates a 'commitment to tackling climate change and to protecting and restoring our natural environment for future generations.' The Bill had its Second Reading in the House of Commons on 26 February. This Bill was being considered by a Public Bill Committee but due to current circumstances the sittings of the Committee have been suspended until further notice. The Committee is now scheduled to report by 25 June

Private Bills

<u>Highgate Cemetery Bill</u>: was deposited with Parliament on 27 November 2019. The
Examination took place on 18 December and the Bill was found to be compliant with
Private Business Standing Orders. The Bill was introduced to the House of Lords and

had its First Reading on 22 January. The Second reading took place on 12 February and was unopposed, so there was no debate. The Bill needed a "Wharncliffe" Examination to comply with certain standing orders concerning the consents of owners, members and directors of companies. The Examination was on 9 March and the bill was found compliant. The bill now proceeds to an Opposed Bill Committee to consider the petitions. No date has yet been set.

Heritage Planning Case Database

 Historic England tweets planning decisions of heritage interest, via @HeritageAdvice, and these are then collated into the Heritage Planning Case Database. This is a searchable online database of appeal and call-in decisions relating to planning permission (that affects a heritage asset) and listed building consent. Cases have been summarised using a standard list of search terms, for ease of use; searches can also be carried out by address, date or decision reference.

Committees

- The UK Environmental Audit Committee has launched the <u>Technological Innovation</u> and <u>Climate Change Inquiry</u>, with its first focus on offshore wind power. Following the Government's Offshore Wind Sector Deal in March 2019, the Committee will consider the opportunities that will maximise the industry's potential, and that challenges it faces in delivering greater capacity. The Committee is inviting written submissions to inform its first session. Submissions should be submitted through the Committee's web portal.
- The DCMS Committee has launched an inquiry into the <u>Impact of Covid-19 on DCMS Sectors</u>. It will consider both the immediate and long-term impact that Covid-19 and the related social and financial measures are having on the wide range of industries and organisations under the Committee's remit. The Committee expects to hold a number of evidence sessions from late April onwards to hear directly from stakeholders, armslength bodies and Government about what is being done and what further support is needed. It is seeking submissions from anyone with answers to the questions in the call for evidence (deadline 19 June).

Community Infrastructure Levy

As noted in the Planning Response to Covid-19 section of this Bulletin (above),
 MHCLG has published <u>guidance</u> for local authorities on Community Infrastructure Levy matters in response to the spread of Covid-19.

Advice

Historic England Advice

- The Reconstruction of Heritage Assets. This new online <u>advice</u> sets out the issues to consider when deciding whether to reconstruct, and if so how best to proceed..
- Responding to Graffiti. There have been a number of graffiti attacks on historic
 buildings and structures during the Covid-19 crisis. Historic England has published
 new <u>advice</u> on how respond to such cases, including on what to do after a graffiti
 incident, and how to obtain professional advice. A technical advice note on preventing
 and removing graffiti is currently in the final stages of preparation.
- Good Practice Advice notes (GPAs) and Historic England Advice Notes (HEANs) are all available on the Historic England website, and are listed in Appendix I to this Bulletin for ease of reference.

Forthcoming Historic England Advice

- Historic England is consulting on a revised version of its Advice Note on *Tall Buildings* (HEAN 4). The revised text is available here. The updated Advice Note reflects changes in the National Planning Policy Framework and recent good practice. It offers useful guidance to those involved with the planning and design of tall buildings (consultation has been extended until 28 May).
- Historic England is consulting on the draft text for a new Advice Note on <u>Commercial Renewable Energy and the Historic Environment</u>. Technologies covered include large-scale development proposals for wind power, solar photovoltaics and biomass and energy from waste (consultation closing date 28 May).
- Following public consultation, publication of a HEAN on *Energy Efficiency and Traditional Homes* is expected shortly.
- A HEAN on *Permission in Principle* is being currently being drafted and should be consulted on soon.

Training

Historic England Training

- In response to Covid-19 restrictions, Historic England is increasing its e-learning and remote CPD provision. HE will be launching new e-learning courses in June, based on previously delivered NPPF Decoded HELM events, and have almost tripled the planned programme of Webinars.
- Some topics are tailored to respond, in part, to Covid-19 and how it is affecting the heritage sector. Topics include *Wellbeing and Heritage* and *Heritage Crime During Lock Down*. HE will also be turning the HELM courses planned for 2020 into webinars and this will include topics such as *Industrial Heritage* and *Design and Place-shaping*.
- Historic England has launched its new *Technical Tuesdays*, series of webinars delivered by its Technical Conservation Team. *Technical Tuesday* webinars usually take place 13:00-14:00, and previous webinars are available online, generally about a

week after the event. Webinars address the following themes, but the offer will be expanded later in the year:

- Beneath the Surface
 - (5 May Earthen Mortars and Plasters)
 - 2 June Fibrous Plaster
 - 7 July Concealed Decoration
- Survey and Inspection
 - (12 May Infrared Thermography)

Other Initiatives

Planning Enforcement Handbook for England

 The Royal Town Planning Institute has published a <u>Planning Enforcement Handbook</u>, including a section on Urgent Works to Listed Buildings, authored by Historic England, and other sections of direct relevance to the historic environment.

Planning Inspectorate

 As noted in the Planning Response to Covid-19 section (above), PINS have issued <u>Updated Guidance on Site Visits</u>, a <u>Statement on Local Plan Examinations</u>, and a <u>Statement on Nationally Significant Infrastructure Projects (NSIPs)</u>.

Reinstating a Road after Street Works: New Edition of the Code of Practice

- Following consultation a new, fourth edition, version of the <u>Specification for the</u> <u>Reinstatement of Openings in Highways</u> has been <u>launched by the DfT</u>. The main changes in the fourth edition are:
 - the introduction of new materials to aid compliance with air voids (compaction) requirements
 - rationalising the process for introducing innovation, to help speed up the introduction of new materials and methods in street works
 - o a new specification for micro trenching
 - o permitting the use of large diameter coring reducing site occupation time.

Current Consultations

- The Department for International Trade is consulting on the UK's <u>Freeport Policy</u>. The
 proposals include tariff flexibility, customs facilitations and tax measures, as well as
 planning reforms, additional targeted funding for infrastructure improvements and
 measures to incentivise innovation (extended closing date 13 July).
- Historic England is consulting on a draft <u>Local Authority Strategic Framework</u> to guide our engagement with local authorities beyond site-specific casework and take account of the organisation's new structure. The framework will support the prioritisation of Historic England resources, and it will also help local authorities to understand what we do, why and how (extended closing date 25 May).
- Historic England is consulting on a revised version of its Advice Note on Tall Buildings (HEAN 4). The revised text is available here (extended closing date 28 May).
- Historic England is consulting on the draft text for a new Advice Note on <u>Commercial Renewable Energy and the Historic Environment</u>. Technologies covered include large-scale development proposals for wind power, solar photovoltaics and biomass and energy from waste (closing date 28 May).
- The Environment Agency is consulting on <u>River Basin Planning: Challenges and Choices</u> (extended closing date 24 September). It is seeking views on:
 - the challenges that limit the benefits society obtains from the water environment in the river basin districts in England (the challenges)
 - o the best way to address these issues (the choices)
- The UK Environmental Audit Committee has launched the <u>Technological Innovation</u> <u>and Climate Change Inquiry</u>, with its first focus on offshore wind power, is inviting written submissions to inform its first session (see Committees section, above).
- The DCMS Committee has launched an inquiry into the <u>Impact of Covid-19 on DCMS</u>
 <u>Sectors</u> and is seeking submissions in response to its call for evidence (see
 <u>Committees</u> section, above. Deadline 19 June).
